UNFINISHED BUSINESS

Domestic Animal Ordinances- Ms. Hughes questioned if this ordinance would only apply to domestic cats or if it would address strays. The purpose of the ordinance is to address stray and feral cats. The Planning Board intends to review definitions included in other Domestic Animal Ordinances.

Invisible Fences- Mr. Wilson pointed out that a commonality between many other municipalities is the requirement that invisible fences be installed no closer than 10-ft. away from the sidewalk with signage. Mr. Wilson offered to share information he already reviewed.

NEW BUSINESS

Food Truck Regulations- Code Enforcement Officer, Dan Wolfe, distributed the Village of Williamsville Local Law on Mobile Food Vehicles and described food truck trends he has witnessed in neighboring municipalities. Discussion was held about where food trucks would park, how to ensure safety, and the current procedure for when food trucks do come into the village. The Planning Board will review mobile food vendor laws from surrounding municipalities.
