- Lyndonville 10 is back in service. Superintendent Woodworth noted the pictures that were taken of the tank that was damaged during shipping and provided the Board with a lifetime warranty from the company on the tank.
- New member's info – Clerk-Treasurer Woodworth inquired if Chief Gerety had obtained the necessary information requested by Orleans County Self-Insurance on the latest members. Chief Gerety didn't recall getting a letter. Clerk-Treasurer Woodworth will work with the members to complete the request.
- Mercy Flight – Chief Gerety noted several citizens came to him with concerns about Mercy Flight not being able to land in the Town of Yates or the Village of Lyndonville after reading an article Jim Simon wrote and may comments from Save Ontario Shores. Chief Gerety contacted Mercy Flight himself to learn that Mercy Flight can land in the Town of Yates and the Village of Lyndonville regardless if wind turbines are put up.

Report – Code Enforcement Young

- Report – 1 - Building permit, 5 - Certificates of Occupancy, 4 - Certificates of Compliance, 2 - Complaints received, 1- 1203 Inspection and 1 - Notice of Violation
- Deputy Mayor Tuk asked Code Enforcement Young what the code is for dumpsters and if he could look into that.

Report – Attorney Schubel

- Cats – Attorney Schubel is working with the family of Mildred Leonard to find a place to take the homeless cats. Attorney Schubel noted Clerk-Treasurer Woodworth assisted in contacting Lollypop Farms who are able to take the cats in small amounts at a time. Attorney Schubel mentioned he will contact the District Attorney's office if the matter isn't able to be resolved.
- Signs – The Board asked Attorney Schubel to review the Village's zoning on signage. The Board would like to see all signs kept off the right-of-way or a certain distance back from the road for those properties without sidewalks. Clerk-Treasurer Woodworth noted that the sign regulations are part of the Village Zoning Local Law and there are several others errors or changes that need to be made that should just be made all at once.
- Solar – Deputy Mayor Tuk noted he has spoke with Chatfield Engineers regarding solar power and both Chatfield Engineers and Attorney Schubel feel that Board should look into it more.

Report – Trustee Covell

- Logics – Trustee Covell asked where things stand with getting the new accounting software. Clerk-Treasurer Woodworth noted the Village has signed the necessary paperwork and paid the 50% down now Logics has to custom build the accounting software specifically for the Village's needs.
- Grants – Trustee Covell inquired if Clerk Part-Time Nicholson could look for a grant to replace the Village's police car. Clerk-Treasurer Woodworth will have her look into it.

Report – Deputy Mayor Tuk

- Patterson Park – Deputy Mayor Tuk asked if something could be done with Patterson Park, as in cutting down some trees or at least trimming them up. Superintendent Woodworth noted all the exotic trees that are in the park it would be a shame to cut any trees down. Superintendent Woodworth also added that the intention of the park was to be a walking park. Clerk-Treasurer Woodworth was asked to have Clerk PT Nicholson to look into some grants for walking parks for sidewalks among other things.

NEW BUSINESS:

- Mayor vacancy – The Board discussed filling the Mayor's vacancy and decided to not make an appointment and let the position be filled at the March 2016 General Election.
- Website – Deputy Mayor Tuk noted he's asked Clerk-Treasurer Woodworth to add a new page to the Village's website called "Notes from the Village Hall" and he will be doing little write ups every so often and encouraged other Board members to do the same. He also asked Clerk-Treasurer Woodworth to post the Village's audit from the State Comptroller's office.
- Sidewalks – Deputy Mayor Tuk noted he wants a 5% retainer withheld on the payment to Pro Construction as the Board and several residents are not happy with the restoration work. The Board would like Pro Construction to come back in the spring to fix the restoration work.
- National Grid – The Village received an email about converting street lighting over to LED in the future.

OLD BUSINESS:

- Planning Board – Attorney Schubel is still awaiting a position from NYS before proceeding with any advisement on a joint or shared Planning Board with the Town of Yates.
- Employee Handbook - Clerk-Treasurer Woodworth is working on the next section to be approved for the next Board meeting.
- Cats – The Board mentioned they would like to see either a local law or code regulating cats.
- Bonadio Group - Clerk-Treasurer Woodworth noted the Bonadio Group has started auditing the Village's 2014-2015 fiscal year and will need to have their engagement letter signed. They will be assisting with filing the Village's annual update document this year as well.

After I offered to give my new address in order to receive the last bill, she explained it was not necessary since it had already been mailed to our old address, in expectation that it would be forwarded by the post office. (We set up forwarding the day we moved, and have been receiving forwarded mail.)

We received this final bill, addressed to our new home, and with the above mentioned overdue fines. I call Terri to see if we could have these fines waived. She explained that first bill had been returned to the village, with a notice from the USPS that the address could not be found. Thus, she had to make many contacts in order to mail the bill to us. Through no fault of our own, the bill has reached us late, after I made the attempt to update our information with the village. I do not believe we have ever paid a bill late to the village. I am asking that as a good citizen of the village, you will grant my request.
