- Mayor McAvoy mentioned the increase in the General Fund expenses due to budgeting for demolition of 15
 Eagle Street.
- Clerk-Treasurer Woodworth explained changes in the proposed budget since the budget workshop meeting:
 - General Fund the Gross Receipts Tax was increased to \$10,500.00 from \$10,200.00
 - General Fund the Treasurer's Fees was increased to \$275.00 from \$250.00
 - General Fund the Sales of Equipment was increased to \$2,000.00 from \$1,500.00.
 - General Fund the Refunds of Prior Years Exp was increased to \$1,200.00 from \$0.00.
 - Clerk-Treasurer Woodworth cut her own pay increase proposed by the Mayor from 3.5% to 2%.
 - Changed the General Fund, Real Property Tax from \$362.763.00 to \$357,034.00. Making the Property Tax rate \$12.507 per 1000.
- Resident Dorothy Covell thanked Clerk-Treasurer Woodworth for cutting her own pay increase to help with the impact on the tax rate increase.
- Trustee Covell mentioned he spoke to officer Larkin about keeping his hours to 25 hours per week and he was ok with that.
- Trustee Woodward Jr. voiced his concern on the Town of Yates contribution toward the Fire Department budget decreasing. He hopes the Public Safety Committee can work on contribution amounts in the upcoming agreement.
- Trustee Tuk inquired when the next re-assessment year was. Clerk-Treasurer Woodworth stated it would be next year, but to keep in mind that Village are an entire year behind on Property Taxes.
