SECTION I. Section §230-2 of the Code of the Village of Lyndonville is hereby amended to provide as follows:

In all cases when water rents are not paid within thirty (30) days after billing, ten (10%) percent of the amount thereof shall be added thereto and collected thereafter; and all water remaining due and unpaid at the time the annual tax levy of the Village is made out shall be included therein pursuant to the Village Law and levied against the real property on which the same have been used and shall be collected with and in the same manner as other Village taxes, with additional fees, charges and penalties incident to the collection of such taxes.

SECTION II. Section §230-18 of the Code of the Village of Lyndonville is hereby amended to provide as follows:

Should the owner of property or consumer of water fail to pay water rents or to comply with any provisions of this chapter and any amendments thereto, the Board of Water Commissioners, in addition to any other remedies granted to it, may discontinue the water supply to such premises.

SECTION III. This Local Law shall take effect immediately upon filing with the Secretary of State.
