Section 190-14 E. of the Code of the Village of Lyndonville is hereby changed and amended so as to provide for an increase in the rate charged per 1,000 gallons of ninety (90%) percent of metered water from \$2.80 to \$2.90. The rate schedule shall be as follows: CLASS CHARGE

Class 1 l service unit, less than 150,000 gpy

Availability charge: \$80.00 per year; \$2.90 per 1,000 gallons of 90% of metered water

Availability-vacant parcel

\$10.00 per year

First service unit

Availability charge: \$80.00

SECTION 2. Section 230-21 of the Code of the Village of Lyndonville is hereby changed and amended so as to provide for an increase in the water rates. The rate schedule shall be as follows:

- A. Inside the Village: a minimum fee of Twenty-Three and 40/100 Dollars (\$23.40) for six thousand (6,000) gallons, plus Three and 90/100 Dollars (\$3.90) per one thousand (1,000) gallons thereafter.
- B. Outside the Village: rural full-use metered service: A minimum fee of Thirty-Three and 30/100 Dollars (\$33.30) for six thousand (6,000) gallons, plus Five and 55/100 Dollars (\$5.55) per one thousand (1,000) gallons thereafter.
- C. Seasonal cottages: May 1 to November 1, water recorded at the master meter; billing June 1, September 1 and December 1.
- D. Tank use: Eight and 00/100 Dollars (\$8.00) per one thousand (1,000) gallons upon application to and approval of the Superintendent of Public Works.
- SECTION 3. All local laws or regulations, or parts or portions thereof that conflict or are contrary to any provision of this local law are hereby repealed.
- SECTION 4. This local law shall take effect June 1, 1996.
