A LOCAL LAW PROHIBITING THE DISCHARGE OF CERTAIN AIR, PUMP, CARBON DIOXIDE OR TOY GUNS WITHIN THE VILLAGE OF LYNDONVILLE

SECTION 1 - PROHIBITED ACTS

It shall not be lawful in the Village of Lyndonville for any person or persons to fire or discharge any air rifle, pistol, pump, or toy gun which discharges any splatball, paint pellet, or any other missile containing paint or dye by means of compressed air, carbon dioxide, spring, or other compulsory agent.

SECTION 2 - SEVERANCE

If any clause, sentence, paragraph, word, section or part of this local law shall be adjudged by any Court of competent jurisdiction to be unconstitutional, illegal or invalid, such judgment shall not affect, impair or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, word, section or part thereof, directly involved in the controversy in which said judgment shall have been rendered.

SECTION 3 - EFFECT

This Local Law shall take effect immediately upon filing with the Secretary of State.

SECTION 4 - PENALTIES FOR OFFENSES

Any person or persons violating any provision of this chapter shall be guilty of an offense and shall forfeit and pay a fine not to exceed Two Hundred Fifty (\$250.00) Dollars for each offense.
