Report – Superintendent Woodworth

- Waste Water Treatment Plant Superintendent Woodworth is obtaining a quote from Zeller Corporation to be able to view the Water Treatment Plant and Waste Water Treatment Plant online. The computer at the Miller Drive pump station stopped working so a new computer was purchased to replace it. Superintendent Woodworth is going to have the old computer repaired to have as a backup for future. In order for the Waste Water Treatment Plant to be viewed online internet service would be needed there. Superintendent Woodworth will look into the options to get internet service, possibly underground. The estimated cost for the upgrades is \$10,000.00 and would be split between water and sewer.
- Leaves The Board inquired if leaf fall was behind this year, Superintendent Woodworth stated they will start pick up next week right on schedule.
- 82 West Avenue Superintendent Woodworth noted that the homeowner of 82 West Avenue had her old water line replaced this week after it broke twice.
- Solar The Board mentioned Albion getting six quotes to have their buildings supplied with solar power. Trustee Tuk will be contacting Chatfield Engineers and Attorney Schubel to obtain their opinions.
- Mixer for Tower Superintendent Woodworth mentioned the water tower will have to be taken offline when the mixer installation happens. The tower will have to remain off line until two bacterial samples are taken with negative results. The proposed date for the installation is the week of November 15th.
- North Lyndonville Road Bridge is tentative to reopen Wednesday.
- Dam John Paul Schepp from Chatfield Engineers is working on the reporting. New York State has concerns of the dam collapsing from ice freeze build up on the dam. The Board mentioned there is usually water going over the dam all winter.
