• KVS - Clerk-Treasurer Woodworth has been battling with KVS regarding setting the Village up with a clean database effective June 1, 2015 per the Bonadio Groups recommendation. Several conversations have been had with KVS that the proper training was not given as well as the figures they were given from the prior bookkeeper to start the Village were incorrect. KVS quoted a minium of \$500.00 to make the requested changes. Clerk-Treasurer Woodworth expressed to KVS the Village will not invest additional tax payers dollars to correct the mass chaos from prior bookkeeping. On May 20, 2015 KVS sent an email to Trustee Tuk agreeing to \$250.00 for the cost of four hours of training if needed and the setting up a clean database would be no additional cost. Clerk-Treasurer Woodworth would recommend the Village agree to the 4 hours of training on the new database at the expense of \$250.00 for now, which will allow Clerk-Treasurer Woodworth time to research other software programs to consider switching to in the future.
