Notice of said Public Hearing was duly published in the Batavia Daily News on August 6, 2022, August 13, 2022, August 20, 2022 and August 27, 2022 and posted at the Yates Town Hall, Town of Yates website, Lyndonville Village Hall, Village of Lyndonville website, Yates Community Library, Lyndonville Post Office, Lyndonville M&T Bank, Dutch Country Store, White Birch Golf Course, and Spencer's the Country Store.

The purpose of such Public Hearing is to consider the proposed formation of a joint fire district to include all territory situated within the Town of Yates Fire Protection District and the entire limits of the Village of Lyndonville, with all such territory being contiguous and thus encompassing the entire Town of Yates, and to hear all persons interested in the establishment of the District.

Brad Pinsky explained how he works with municipalities to create Fire districts. He explained that he is completely neutral without any allegiance to one side or the other which is important. He explained why we were here today and said that this meeting is a public hearing and all questions are welcome. He discussed the proposal of creating a joint fire district which means that it includes a Village and at least a part of the Town. In this case, it includes the Village and every square inch of the Town. It will bring all of the fire protection under a new government and it puts all fire protection at an equal playing field. There will be the following changes:

- The Fire District will be administered by a board of 5 Commissioners. These decisions have already been made by the Boards. They will be elected annually by the residents to allow for a lot more participation by the residents. The first 5 Commissioners will be appointed by the Town Board; the Village and Yates Boards have already agreed on the first 5 Commissioners. They will serve for 1 year until December 2023. On the second Tuesday of December 2023 the residents will elect 5 new Commissioners for a 1, 2, 3, 4 and 5 year term.
- 2) There will be a lot more public input when it comes to Fire District spending. The public must approve all financing. All of the fire budgets are subject to public input through public hearings and must be voted on by the residents within the District.
- 3) The Fire District rate will be equalized- everyone will pay the same rate per thousand inside and outside of the Village.

PUBLIC COMMENT

Ed Jay, Town of Yates, asked what an equalized tax rate was based upon, is it assessments of homes?

Brad Pinsky said yes, the total taxable assessed valuation. The Fire District tax is an ad valorem tax like the Town tax rate and is applied the same way. Everyone will pay the same rate per thousand based on their assessment.

Scott Goetze, Town of Yates, asked if the fire department will have the same opportunity to do mutual assists to other communities. Will they be able to go out of district?

Brad Pinsky said yes, nothing operationally changes at the fire department. Fire protection will not change in any way. It may improve because now we will have 5 community members focusing only on fire protection. He believes that the fire department is fully in support of this.

Members of the fire department replied yes.

Supervisor Simon said that the Fire Commissioners do not have the authority to dictate operations to the fire company.

Brad Pinsky said correct, they are strictly prohibited by law from interfering in the fire company's operations.

Scott Goetze asked if the Commissioners will work with the Chief and his support staff to discuss the needs of the fire department. Will they be expected to supply technical data to support their requests? Are the Commissioners expected to go out and research or can they rely on the Fire Chief to supply that information?

Brad Pinsky said that this is one option. The Commissioners can form a committee of their own or they can rely on the fire department to go out for equipment purchasing and bidding. Fire districts have to bid for all of their equipment. The Fire District laws are modeled after the Village laws. He also said that there is not a single executive to the district. There is not a Supervisor or Mayor of the Fire District. No one Commissioner has the authority to do anything; it takes a quorum and 3 Commissioners present to take any action.

Supervisor Simon added that there can be a Chair amongst the 5 Commissioners. There will also be a Treasurer and a Secretary of the Fire District.

Brad Pinsky explained that by law there has to be a Secretary. The Fire District will be subject to FOIL and open meeting laws. The Secretary will post notices, may support a website, take minutes, and make sure that the public has access to all records. It's a big job.

There are 2 choices for a Treasurer- either a Treasurer can be elected for a 3 year term by the public which he very much opposes because if you get a bad Treasurer you're stuck with them for 3 years or the 5 Commissioners can choose and appoint a Treasurer that is qualified and willing to do the work. It's a big obligation because the law heavily regulates what a Treasurer of a Fire District can and cannot do. The Town and Village have decided on an appointed Treasurer for 1 year terms. They will do all public reporting. By March 1st, they have to put out the AUD for the public which will be online. This Village already itemizes all of the expenses for the Fire Department which is not the norm. Most of the time you can't figure what is spent in the fire company but it's much easier in Lyndonville because the financials are already itemized. We will see the same transparency in the new Fire District.

Scott Goetze asked if the Commissioners will be signing any contracts for their initial 12 month appointments by the Yates Town Board. He is good at setting up programs but has no interest in going beyond that. He wants to make sure that there is no obligation for the current Commissioners to sign contracts at the end of their 12 month appointment. He only asks because this is new to all involved. He asked how many months/years will the Commissioners have attorney advice on retainer.

Brad Pinsky said that they will not have to sign any kind of a contract and they are free to quit at any time. He said that the Commissioners would have attorney advice until the end of the year. He said he would love to work with the new District after that but they would be free to hire any Attorney. Brad will be the attorney through this whole process.

Mayor Belson said that Brad Pinsky was the Lyndonville Fire Department's attorney prior to this process. Brad has been their attorney for 10-12 years.

Brad Pinsky said yes, since the Larry Lonigan days. He's helped with the Fire Company's by-laws, tax returns, tax status and annual filings and reports.

Supervisor Simon said that they had asked the fire company to give the Town Board a proposed budget and that there was a good \$4,000.00 - \$5,000.00 put into the budget line for legal representation/attorney retainer for next year. A

Commissioner would review that line to consider if that is enough or if it's too much; he thinks that there should be some amount in that line for legal representation.

Brad Pinsky said that what they normally propose to do is start on the administrative policies, financial policies, personal conduct policies like workplace violence and sexual harassment, OSHA and PESH- things that are very specific to Fire Districts to start getting the new district ready for January 1st. He has found that he is very active with the new District for a year and then after that they usually have got it. He usually talks most with the Secretary and the Treasurer. His anticipated legal costs for the District are

\$2,500.00 a year once everything is in place. He wants to make sure that the new District succeeds. He added that he has found through his years both as an attorney and serving personally in a fire company that Fire Commissioners usually serve for many, many years. There is something about the job that people love to do. He believes it's because they are administering emergency services for the betterment of their community to make sure that there is fire protection.

Mayor Belson said that the footprint for this has already been set up.

Councilman Riggi submitted comments on the implementation of the Town of Yates Fire District to be made a part of the permanent record. He congratulated the Town, Village and Fire Department for their efforts to get to this point and he believes that we are close and that there may be value in a separate Fire District for the Town. He feels that as an elected representative of the Town, his job is to ensure that all decisions benefit the constituency. He believes that there are still questions to be answered and will be voting no on all resolutions for the following reasons:

- 1- How do we define a successful fire district?
- 2- What metrics have been developed to track fire district performance to its mission statement both operationally and financially?
- 3- Given village and town population, what is the tangible value of an additional taxing authority to the constituency?
- 4- Will the advent of a separate fire district, in and of itself increase LFD membership, as has been indicated, given that the new taxing authority will keep taxes the same?
- 5- What improvements in services will be realized from the advent of a Fire District?
- 6- What qualifications are required for a successful financial and operational function of the fire district and are those qualifications currently represented in the fire district management?

He added that with every one of these questions, he would be happy to assist. He believes that these are the questions that are probably on the minds of the Fire District Commissioners and asks how we can ask the new Commissioners to "commission" and manage the new taxing authority without giving them the tools to accomplish the work. He said we need to ensure that the mission, metrics, resources and staff are in place to successfully operate a new taxing authority. If these questions and concerns can be addressed in the short term, then he would be an enthusiastic "Yes" to the Fire District.

Supervisor Simon said that his process to this point in forming a new Fire District has been formed by a number of things such as, the annual knock down drag out fights with the Village and the Fire Chiefs over the budget. A lot of times this did not involve any expertise of fire service on his part, just questions that he was used to asking from his long career in the Air Force. Some questions were answered, some left unanswered. He was approached 6-7 months ago by members from the Fire Company and the question of a Fire District started to take root. He was hesitant at first but wanted to have the conversation. There were points along the way where he had his doubts because most of the people in this room have generational ties and he and Councilman Riggi do not so he has felt like an outsider at times and wondered if there was a political gambit here or something that does not meet the eye. Because of the way that he and Councilman Riggi came on the Yates Town Board, they have always had to think 3-4 moves down the road before they made any decisions because they didn't know where people were coming from because they didn't have the personal background. He believes that people have found that he and the Yates Board asks a lot of questions because they feel like they're doing their due diligence. Then they hit an interesting moment when they thought they knew how the process of appointing commissioners worked but it was incorrect so that set them back. Once they realized that the Town Board made all of the initial appointments they asked for input form the Mayor and the Fire Company and received great input. He believes that the 5 Commissioners chosen are a great representation of this area. Lastly, behind the scenes they saw that there was some work being done to clarify the budget. He said the work put in to the draft budget was very informative and gave the board comfort knowing that they would have a sane budget that was not going to set a whole new level of taxation to the constituents. Ultimately he is a yes vote with all of the same concerns as Councilman Riggi, who had good questions. Supervisor Simon would also be willing to help in answering these questions.

Councilman Hrovat said that she has only been on the Town Board a couple of years and was surprised at the amount that the Town contributes toward the fire budget; Town- 80%, Village- 20%. She was very confused at the increase in the budget from year to year and was frustrated because the Town Board was constantly battling to get information and a copy of the fire budget. She explained that the Lyndonville Fire Department was always there for her family and she appreciates that and backs the Fire Department 100%. She struggled not having the answers she was looking for so the Board put together committees to figure out what the increases were for. She believes that it's hard to spend the amount of time that is really needed to go back and forth with everything else that's going on. She said that the Town Board is not comprised of experts that know about fighting fires, equipment needs or training requirements. They have to consider the needs/wants of their constituents and are responsible for a lot of money. She recognizes that you cannot put a dollar value on a person's life but the bottom line is that they are responsible for trying to figure out how to pay for the annual increases. This is a win because now there will be a group of people that know what they need, what training is required and will be able to stand up and say this is what we need and why. The new District will be able to justify their budgets and will have accountability to the residents. She is 100% for this and has great faith in their success.

Councilman Suhr said that he was part of the interview process for the new Commissioners and he has 100% confidence in the Boards appointments. He said that if they can't do it, nobody can do it. He believes they have 5 great guys and that's all he needs to know.

Councilman Chaffee said that when he got voted on the Board, this has been the majority of what the Town and Village want and he has not heard anybody that disagrees with the joint Fire District so he will be a yes vote.

Upon the passage of thirty (30) days following publication of this notice, the Town Board for the Town of Yates and the Board of Trustees of the Village of Lyndonville shall meet to pass a resolution confirming the initial appointment of five fire commissioners and their terms of office, as identified in the joint resolution establishing the Lyndonville Joint Fire District, who shall be thereafter elected pursuant to Article 11 of the Town Law, or may have approved the commissioners which shall automatically be deemed approved upon passage of this permissive referendum period.

SCHEDULE A

Proposed Plan for the Dissolution of the Yates Fire Protection District

The Town Board for the Town of Yates hereby proposes, pursuant to General Municipal Law, section 774, the following as its dissolution plan for the dissolution of the Yates Fire Protection District:

- (a) the name of the local government entity to be dissolved is Yates Fire Protection District;
- (b) the territorial boundaries of the entity to be formed in place of the fire protection district to be dissolved is the entire territory of the former Yates Fire Protection District in the Town of Yates and all of the territorial limits of the Village of Lyndonville in the County of Orleans, New York;
- (c) the local government entity to be dissolved is a fire protection district located within the territorial boundaries of the Town of Yates, County of Orleans;
- (d) the fiscal estimate of the cost of dissolution is less than \$500.00;
- (e) there are no public employees of the fire protection district to be transferred or eliminated;
- (f) the entity has no assets; the entity does not own any real or personal property; the fair value thereof in current money of the United States of the entity's assets is \$0.00;
- (g) the entity has no liabilities or indebtedness, bonded and otherwise; the fair value thereof in current money of the United States is \$0.00;
- (h) there are no agreements entered into with the Town of Yates to carry out the dissolution;
- (i) the manner and means by which the residents of the entity will continue to be furnished municipal services following the entity's dissolution are by the services of the Lyndonville Fire Department which will be the fire department of the Lyndonville Joint District upon its establishment;
- (j) as there are no assets or liabilities of the entity, there are no terms for the disposition of the entity's assets and the disposition of its liabilities and indebtedness, including the levy and collection of the necessary taxes and assessments therefor;
- (k) there are no local laws, ordinances, rules or regulations of the entity, and thus, none shall remain in effect after the effective date of the dissolution and none shall remain in effect for a period of time other than as provided by section seven hundred eighty-nine of this title;
- the effective date of the proposed dissolution of the Yates Fire Protection District is contingent upon the establishment of the Lyndonville Joint Fire District and dissolution will be effective upon the commencement of administrative and operational activity of the Lyndonville Joint Fire District;
- (m) the public hearing on the dissolution of the Yates Fire Protection District, shall be held on the 1ST day of September, 2022 at the Lyndonville Fire Department, which shall commence at 6:00 pm;
- (n) there are no other matters desirable or necessary to carry out the dissolution of the Yates Fire Protection District.
